

Vision, Mission & Faith

Vision: Happy childhood & child-centric education for all

Mission: To transform 'out-of-system' children into self-reliant citizens by giving them love, care, empathy and education through a free residential, eco-friendly, coeducational school.

Faith:

- Natural resources and human resources are two essential resources needed for the development of any society, nation and the world.
- Every educated person with values is an asset to his/her country in particular and the world at large.
- Education is an important tool to transform ordinary human beings into human resources. India has more than 130 Crore of human beings. We have not paid adequate attention to transforming these human beings into human resources.
- Our current education system considers all children as machines who can learn a predetermined textual content, in a predetermined time interval and in a predetermined way. When children cannot learn this way, we label them as dull/stupid. The truth is that children have varied emotions, varied learning abilities and varied learning interests.
- The education of a child depends on several external factors apart from the child's inherent ability to learn, such as place of living (whether in a village, urban area, or tribal area), parent's education, parent's financial status, the emotional atmosphere at home, peer group, infrastructure at school, teachers' attitude and knowledge, prevailing Education system, etc...,
- An uncluttered mind is a prerequisite for learning. Love, Care and Empathy are the ingredients for creating an uncluttered mind.
- Education has several perspectives: children's parents', schools', teachers', policy-makers', nation's, etc...



Relevance of Kaliyuva Mane

- Education empowers an individual permanently & every empowered individual in turn empowers the society and nation. For a society to progress, two ingredients are vital: natural resources and human resources. India has better natural resources than Japan. Due to poverty, ignorance of the parents and rigidity of the formal schools, many children remain out-of-school. In this context, Kaliyuva Mane is a sincere attempt to discover a non-formal school model to mainstream the out-of-school children. Kaliyuva Mane is a free, residential, co-educational, eco-friendly, non-formal school which is working with the principle, 'School for Children' rather than 'Children for school'.
- According to a survey conducted by the state's Department of Education, the number of out-of-school children in Karnataka rose from 14,000 in 2017-18 to 70,116 students in 2018-19. The National Sample Survey Organisation's 2017-18 household survey put the number of out-of-school children in India (6-17 years) at 3.22 crore. Due to COVID, the data for 2019-20 & 2020-21 will be definitely very high. These out-of-school children belong to us, belong to our society, belong to our nation and to our world. These out-of-school children deserve a second chance to get education. Kaliyuva Mane gives them a second chance to join the mainstream. Kaliyuva Mane has bent many rules in the favour of children. It has carried out many experiments in this field. A new non-formal education system has evolved.
- The Hon'ble High court of Karnataka State also had filed Suo moto Public Interest Litigation in the year 2013 itself about this issue of out-of-school children. Kaliyuva Mane may be a model school to educate 'out-of-school' children.
- The National Council of Educational Research and Training (NCERT), an autonomous organisation of the Government of India has produced a 40 minutes' documentary film on Kaliyuva Mane. We request you to watch this at the following link: https://youtu.be/fDRCGbPOIEW
- Learning of a child depends on many factors such as child's inherent ability to learn, child's interest, child's pace of learning, parent's education, financial status, place of living (tribal location/rustic location/urban location), infrastructure at the school, teachers' knowledge and passion, education system etc. Kaliyuva Mane as far as possible tries to consider all these factors while educating a child.
- As per the Annual Status of Education Report (ASER) about 50% students from class 5 and 25% students from class 8 cannot read a simple text which has a difficulty of class 2 level.
- When Infosys founder Dr N.R. Narayana Murthy visited Kaliyuva Mane, his remarks in our visitor's register were: "I am so happy to see the wonderful work being done by Mr. Ananth & team to empower the 'Forgotten India'. More power to you! Best wishes!".
- In the year 2011, when the automobile giant Mahindra & Mahindra launched the 'Spark The Rise' contest, inviting ideas from the Indians for the development of India, our project, 'Education of

rural out of system children', emerged as runners up in the grand finale among 1346 projects which were featured and won a grant of ₹20 lakhs.

■ World Bank has warned of a learning crisis in India: "...In rural India, nearly three-quarters of students in grade 3 could not solve a two-digit subtraction such as 46 – 17 and by grade 5, half still could not do so.... This learning crisis is moral and economic," World Group President Jim Yong Kim said. "When delivered well, education promises young people employment, better earnings, good health, and a life without poverty. For communities, education spurs innovation, strengthens institutions, and fosters social cohesion. But these benefits depend on learning and schooling without learning is a wasted opportunity. More than that, it's a great injustice."






Few updates in the administrative sector:

10th Standard results for 2020

Harish R (16 years)

Harisha's father was suffering from some psychological issues. He was uneducated. He was working in a mutton Shop. He passed away when Harisha was 9 years old. Even now, his mother works as domestic help in Bengaluru. Harisha studied from 1st standard to 4th standard in a Government school. Afterward, Harisha's mother admitted him to a hostel in Bengaluru. He continued his education in another Government school. He was labeled as 'intelligent'. His mother again admitted him to one more orphanage in Mysuru. Harisha joined yet another Government school.



But as per Government order, all boys in that hostel were shifted to Government-run Balakara balamandira. Thus, Harisha joined Government run Balakara balamandira. Balakara Balamandira officials brought him to Kaliyuva Mane.

In the 10th standard examination held during June-July 2020, Harisha passed scoring 62.4% of marks. (English medium)

R Kalavathi(16 years)

R Kalavathi lost her father when she was 10 years old. Her mother works as domestic help. Kalavathi studied from 1st standard to 5th standard in a Government Kannada medium school. Then her brother admitted her to "Kaliyuva Mane". When she joined Kaliyuva Mane, she did not know how to read and write Kannada properly. She was not in a position to solve addition





and subtraction sums. She did not know the English alphabet.
But Kalavathi did not lose focus. In the 10th standard public examination held during June-July 2020, she passed scoring 56.1% of marks.

Manju M (15 years)

Manju M belongs to a rural BPL family from a tribal area which is about 30 kms. from Mysuru city (Gumachanahalli). Father has studied up to 3rd standard. Mother is uneducated. Manju studied up to 4th standard in a Government school. Then he joined a Private school in the city, staying with his sister. But they could not afford the high fees charged by that school. Later Manju's parents admitted Manju to "Kaliyuva Mane". Manju passed scoring 52.6 % of marks.



Bhoomika R (Age 15 years)

Bhoomika R lost her father during early childhood. Bhoomika's mother was (is) an illiterate. She had to take care of herself along with the added responsibility of her five children. Bhoomika's mother started working as a daily wage earner in a construction company. She also started working as a domestic help in the mornings. Bhoomika never joined any school due to poverty, ignorance and compulsions of life. At the age of 7 years, she was sent to Bengaluru. There she



started taking care of a one-year-old baby. Thus, two years passed. The owner of the house, Smt. Uma where Bhoomika's mother was working advised her to admit Bhoomika to "Kaliyuva Mane". Then Bhoomika was about 9/10 years old. She did not have any documents such as TC, Birth Certificate, Aadhar, etc.

Because of the emotional ambiance prevailing in Kaliyuva Mane, Bhoomika gradually started evincing interest in studies. She started learning from පපත, abcd, & 1,2,3,4 etc. Bhoomika passed the 10th standard public examination with flying colours.

Lakshmi S (16 years)

Lakshmi S belongs to a rural BPL family. Lakshmi's mother works as domestic help. Her father works as a daily wage earner under a construction contractor. The family is living in a garage of a well-to-do family. Parents are not educated. But they knew the power of education. They admitted their daughter to an English medium school. Lakshmi completed 2nd standard there. But they could not pay the fees. Smt. Sharada, a teacher cum volunteer intervened and advised Lakshmi's parents to admit Lakshmi to "Kaliyuva Mane". Lakshmi passed the 10th standard public examination with flying colours.





Mahesh Aradhya(16 years)

Mahesh Aradhya's uneducated father works as a daily wage earner in Heggadadevana Kote near Mysuru. But he could read Kannada. Mahesha studied up to 2nd standard in his village. When he was 8 years old, he lost his mother. Then his father admitted Mahesh to "Kaliyuva Mane".

He liked working in Kaliyuva Mane and was not interested to sit in classrooms milking cows, plumbing works, electrical work, welding, hair cutting, etc. Mahesh passed the 10th standard standard public examination with flying colours.



Pre-University results

Two alumni of Kaliyuva Mane had appeared for the PUC examination. Both of them passed with flying colours. Both were studying commerce. Divya, a dyslexic girl from an underprivileged broken family secured first class scoring 93 in Accountancy, 91 in computer science, and 60 in Economics (Out of 100 in each subject). Kiran, a rural first-generation learner secured second class. We congratulate both of them for their hard work.







Success Stories:

Illiterate rural youth becomes educated, in turn, educates his daughter.



Shivalingu, hails from Mellahalli village, on the outskirts of Mysore. He dropped out of school, without completing the first standard. At the age of 20, he came in contact with Mr. Shamanna - who used to visit villages and teach Kannada for rural youth free of cost. Through his help, Shivalingu learned to read and write Kannada. Then Mr. Shamanna introduced him to Ananth Kumar - the founder of Kaliyuva Mane. Shivalingu's passion to learn the basics of English was so much that he used to come twice a week from Mellahalli to Srirampura by bus. He purchased a tape recorder to record the lessons. In the process, he understood the power of education.

Later, he got married. He admitted his daughter to the only English medium school of that village.


She completed her class VII. There was no English medium High school in that village. Shivalingu tried a seat for his daughter in English medium schools of urban Mysore, but could not afford the huge fees. Thus Soundarya - Daughter of Shivalingu joined Kaliyuva Mane-a free residential non-formal school. Soundarya, completed three years of high school education within two years in Kaliyuva Mane. In 2015, she completed the 10th standard with flying colours. In 2020, she completed her B.Sc. degree with distinction, securing 85% marks. Now she is pursuing her M. Sc. Kaliyuva Mane

Our alumni Hemanth J completed basic mountaineering course successfully securing A grade.

Campus Development:

With the guidance of Isha Foundation Volunteers, our children worked with enthusiasm in the landscaping project in front of the school block. Even now children sweat out for an hour and grow vegetables.



















Infrastructure improvements:

Dining, Kitchen and accommodation for Resident staff.

We have constructed 'Ananpoorna block' consisting of dining hall, Kitchen and accommodation for male staff members with the support of INSAF (Indian School Alumni & Friends) and Dr. Oswal brothers. Now children can comfortably eat and enjoy their meals. Now 200 members can have their food at a time including children and staff members.

Successful COVID Management:

When the whole country was under the grip of COVID-19 and its attendant negative impact on people, Kaliyuva Mane strived hard to keep children safe. We took the following steps and managed the crisis successfully.

- 1) All children stayed on the campus.
- 2) Any newly joined child or staff member was being isolated and observed for 2 weeks, then integrated with the rest of the children and staff members.
- 3) All teachers and non-teaching staff stayed on the campus except three, i.e. repair & maintenance person, security person and one office staff. These three people took head-bath soon after they arrived at Kaliyuva Mane, changed their dresses, wore a mask and maintained physical distance before they started their work.
- 4) Children spent most of the time in open areas. The campus is almost 3 acres. By design, most classes are open-type.
- 5) First time, the gates of Kaliyuva Mane were closed. On the arrival of visitors, the gate was opened, their hands sanitized and thermal scanning done, and they were made to wait in the visitors' lounge.
- 6) Trained persons wearing a mask and carrying sanitizers did outdoor duties like shopping. All materials brought from outside were quarantined for at least 12 hours.
- 7) Children performed Yogasana in the mornings and Pranayama in the evenings.
- 8) Children were given 'C' vitamin tablets and 'Kashaya', protein powder to boost their immunity.
- 9) In the evening, all prayed together for the pandemic to end.

But not even a child was infected due to God's Grace.

The Negative impact of COVID

Many children did not have stable homes. Therefore, we decided to keep them on the campus, instead of sending them home. But COVID had its impact on Kaliyuva Mane.


- We insisted all staff members stay on campus. Many staffs could not stay & left due to their personal issues. We had to recruit new staff members and train them. It was a challenging task and incurred additional expenditure.
- 2. We had to incur additional expenses to protect children and staff from COVID-19. We had to buy sanitizers, thermal scanner medicines, etc.
- 3. Normally we used to take children out for excursions. They used to go home & spend time with their parents/guardians once in a while. But they had to stay away from their relatives throughout the year. This impacted negatively on their emotions and feelings.
- 4. Kaliyuva Mane used a to attract lot of visitors. But this reduced drastically and hence affected the contributions. The Paper Empower Project of collecting and selling old newspapers also stopped.



Collection of happenings:

Skype classes by INSAF members:

Smt. Padma Cariappa and Smt. Madhavi Continued their efforts this year also. Smt. Padma Cariyappa taught Social Science and Smt. Madhavi is teaching science to 10th standard children apart from honing their English skills. This year, they introduced Smt. Nalini Daliparthy to Kliyuva Mane. She taught Biology to 10th standard children. We convey our sincere gratitude to the three of them for their relentless efforts to help Kaliyuva Mane's children.





D.C.'s VISIT

Mysore district Deputy Commissioner Mr. Abhiram G. Sankar visited Kaliyuva Mane on 1st February 2020. He evinced interest in all the activities and appreciated our work. He left positive remarks and became our paper donor. He donated around 250 Kgs of old newspapers from his home.


