All this progress would not have been possible without active support and empathy from supporters like you. We sincerely convey our sincere gratitude to each and every one of you. Kaliyuva Mane welcomes every one of you with open arms to interact with the kids and witness the functioning of Kaliyuva Mane.

We are very happy to place this Annual Report in your hands.



Vision, Mission & Faith

Vision: Happy childhood & child-centric education for all

Mission: To transform 'out-of-system' children into self-reliant citizens by giving them love, care, empathy and education through a free residential, eco-friendly, coeducational non-formal school.

Faith:

- Natural resources and human resources are two essential resources needed for the development of any society, nation and the world.
- Every educated person with values is an asset to his/her country in particular and the world at large.
- Education is an important tool to transform ordinary human beings into human resources. India has more than 130 Crore of human beings. We have not paid adequate attention to transforming these human beings into human resources.
- Our current education system considers all children as machines who can learn a predetermined textual content, in a predetermined time interval and in a predetermined way. When children cannot learn this way, we label them as dull/stupid. The truth is that children have varied emotions, varied learning abilities and varied learning interests.
- The education of a child depends on several external factors apart from the child's inherent ability to learn, such as place of living (whether in a village, urban area, or tribal area), parent's education, parent's financial status, the emotional atmosphere at home, peer group, infrastructure at school, teachers' attitude and knowledge, prevailing Education system, etc...,
- An uncluttered mind is a prerequisite for learning. Love, Care and Empathy are the ingredients for creating an uncluttered mind.
- Education has several perspectives: children's parents', schools', teachers', policy-makers', nation's, etc...



Relevance of Kaliyuva Mane

- Education empowers an individual permanently & every empowered individual in turn empowers the society and nation. For a society to progress, two ingredients are vital: natural resources and human resources. India has better natural resources than Japan. Due to poverty, ignorance of the parents and rigidity of the formal schools, many children remain out-of-school. In this context, Kaliyuva Mane is a sincere attempt to discover a non-formal school model to mainstreamthe out-of-school children. Kaliyuva Mane is a free, residential, co-educational, eco-friendly, non-formal school which is working with the principle, 'School for Children' rather than 'Children for school'.
- According to a survey conducted by the state's Department of Education, the number of out-of-school children in Karnataka rose from 14,000 in 2017-18 to 70,116 students in 2018-19. The National Sample Survey Organisation's 2017-18 household survey put the number of out-of-school children in India (6-17 years) at 3.22 crore. Due to COVID, the data for 2019-20 & 2020-21 will be definitely very high. These out-of-school children belong to us, belong to our society, belong to our nation and to our world. These out-of-school children deserve a second chance to get education. Kaliyuva Mane gives them a second chance to join the mainstream. Kaliyuva Mane has bent many rules in the favour of children. It has carried out many experiments in this field. A new non-formal education system has evolved.
- The Hon'ble High court of Karnataka State also had filed Suo moto Public Interest Litigation in the year 2013 itself about this issue of out-of-school children. Kaliyuva Mane may be a model school to educate 'out-of-school' children.
- The National Council of Educational Research and Training (NCERT), an autonomous organisation of the Government of India has produced a 40 minutes' documentary film on Kaliyuva Mane. We request you to watch this at the following link: https://youtu.be/fDRCGbPOIEW
- Learning of a child depends on many factors such as child's inherent ability to learn, child's interest, child's pace of learning, parent's education, financial status, place of living (tribal location/rustic location/urban location), infrastructure at the school, teachers' knowledge and passion, education system etc. Kaliyuva Mane as far as possible tries to consider all these factors while educating a child.
- As per the Annual Status of Education Report (ASER) about 50% students from class 5 and 25% students from class 8 cannot read a simple text which has a difficulty of class 2 level.
- When Infosys founder Dr N.R. Narayana Murthy visited Kaliyuva Mane, his remarks in our visitor's register were: "I am so happy to see the wonderful work being done by Mr. Ananth & team to empower the 'Forgotten India'. More power to you! Best wishes!".
- In the year 2011, when the automobile giant Mahindra & Mahindra launched the 'Spark The Rise' contest, inviting ideas from the Indians for the development of India, our project, 'Education of



rural out of system children', emerged as runners up in the grand finale among 1346 projects which were featured and won a grant of ₹20 lakhs.

■ World Bank has warned of a learning crisis in India: "...In rural India, nearly three-quarters of students in grade 3 could not solve a two-digit subtraction such as 46 − 17 and by grade 5, half still could not do so.... This learning crisis is moral and economic," World Group President Jim Yong Kim said. "When delivered well, education promises young people employment, better earnings, good health, and a life without poverty. For communities, education spurs innovation, strengthens institutions, and fosters social cohesion. But these benefits depend on learning and schooling without learning is a wasted opportunity. More than that, it's a great injustice."

1. Dhanush:



Dhanush is from rural BPL tribal family. His father is a driver. At the age of 11 years, he lost his mother. He completed his 6th standard from Bharatha Matha Vidyasamsthe. Then his maternal uncle admitted him to Kaliyuva Mane on 07-06-2015. At the time of joining, a small informal test was conducted to check his academic level. He couldn't write basic Kannada and English words. Then he was taken to the clinical psychology department of All India Institute of Speech and Hearing (AIISH), Mysore for an academic and psychological assessment. According

to the report, his IQ was 78 and his grade score was equivalent to class I level on 15-06-2015 at the age of 11 years 5 months. His academic level as per the report was "Below Average Intelligence – Slow Learner with Academic Delay and Learning Difficulty". He fell under the category of "Children with special needs". Special and one-to-one attention was given to him by the teachers in classes, so he could pass the 10^{th} standard board exam in April 2021 by scoring 60.48% from Pragathi Team. His AIISH report is given below.

This is to certify that Dhanush MP s/o Mr. Prabhakar-Late Mrs. Sheela, aged 11 years 6 months, class VII (State Syllabus-Kannada Medium) undergoing coaching at Kaliyuva Mane (An Alternative School for Underprivileged) run by Divya Deepa Charitable Trust, Kenchalagudu Village, Manandavady Road, Rayanakere Post, Jayapura Hobli, Mysore: 570 008, Karnataka, resident of #Mudala Beedu Village, Anukana Halli, Saligrama, KR Nagar Taluk, Mysuru: Karnataka, bearing CRF Nos. 404554 was registered on 19th May, 2015, at this Institute. As per records, the student is diagnosed as functioning at the intellectual level of "Below Average Intelligence-Slow Learner with Academic Delay and Learning Difficulty"-a condition which is currently classifiable under the category of student with special needs having equivalent of 40 % intellectual disability. His current level of intelligence and adaptive behavior as assessed on standardized psychological tests is around 9 years (IQ: 78). There is history of delay in all developmental milestones. Academic history and current performance on achievement tests shows that his overall grade score is equivalent of class I level.

Owing to his condition, the student falls under the category of 'children with special needs' or 'disadvantaged child' and becomes entitled for such illustrative list of benefits or concessions as mentioned overleaf.

2. Prajwal P:



Prajwal P belongs to a socially disadvantaged BPL family. His mother is an illiterate and works as a tailor. He and his mother stay in a rented house in Mysuru. When he was 5 years, his father abandoned them. His distant relative Mr.Nagesh was instrumental in admitting Prajwal P to Kaliyuva Mane, when he was 6 years old. He passed the 10th standard in the year 2021 scoring 83.52% from the "Pragathi Team". Now he is pursuing PUC (Arts) at Government Pre University College, Vontikoppal.

3. Shashank H.M:



Shashank H.M belongs to BPL family. His father runs a small roadside hotel. His mother is a housewife. His family stays in a rented house. His father has studied up to 5^{th} standard and his mother has passed 2^{nd} PUC. He is the only son to his parents. He studied from 1^{st} standard to 3^{rd} standard in a private convent in H.D. Kote village, staying at his grandparent's house. He studied 4^{th} and 5^{th} standard in Gurur village in English medium, staying with his parents. Then he studied 6^{th} standard in Puttur, staying in a private hostel. Later he joined

Kaliyuva Mane as a day scholar in the year 2017, staying with his parents. Then his father was working as a car driver. He used to come to Kaliyuva Mane as a day scholar. He was weak in studies. So, he joined Kaliyuva Mane as a resident scholar in the year 2018. He was lagging in studies. So, teachers of Kaliyuva Mane, advised his parents to take him to the clinical psychology department of All India Institute of Speech & Hearing for a psychological and academic assessment. After elaborate testing they gave a psychological report. According to the report, his IQ was 100. But he was diagnosed as 'functioning at the level of "Average Intelligence-At Risk for Academic delays and Learning Difficulties". He had problems with reading, writing or spellings of class four upwards in English and Kannada, although his primary and middle school was in English medium, when he was 14 years old. He needed a structured learner paced remedial teaching program. He belonged to the category 'children with special needs".

At Kaliyuva Mane, already learner paced teaching program was in place. Because of this, he could pass the 10th standard board examination in the year 2021, at the age of 16 years, from 'Pragathi' team, securing 85% of marks. Now he is studying II year PUC-Commerce, in JSS College. His AIISH report is given in the next page.

This is to certify that Shashank HM s/o Mr. Mohan Kumar-Mrs. Anitha, aged 14 years, student of class VIII (State Syllabus-Kannada Medium) at Kaliyuva Mane (An Alternative School for Underprivileged), run by Divya Deepa Charitable Trust, Kenchalagudu Village, Manandavady Road, Rayanakere Post, Jayapura Hobli, Mysore: 570 008, Karnataka, resident of #Mahadevpura, 8th Cross, JP Nagar, Mysore: Karnataka, bearing CRF Nos. 487853, was registered on 31st December, 2018, at this Institute. As per records, the student is diagnosed as functioning at the level of "Average Intelligence-At Risk for Academic Delays and Learning Difficulties". Past history shows normal developmental milestones. His current level of intelligence and adaptive behavior as assessed on standardized psychological tests is age appropriate (IQ: 100) with overall grade level matching primary school.

The student shows difficulties in solving divisions with zero in numerator. He has problems in reading, writing or spellings of class four upwards in English and Kannada (although his primary and middle school was in English medium), does not solve LCM/HCF, cannot explain fractions, prime numbers or integers, and does not give out formula for simple/compound interest or measurements in middle school level basic geometry.

The student requires a structured learner paced remedial teaching program with stress on oral and practical skills rather than theory driven writing work. Owing to his condition, the student falls under the category of 'children with special needs' or 'disadvantaged child' and becomes entitled for benefits or concessions especially those related to inclusion in regular school, avoidance of pressurized learning, providing learner paced activity based instruction, allowance for oral work in place of writing, extra time, choice of alternate subjects, and objective type question papers to accommodate the slowness in the child. Periodic review is recommended at this institute before a final diagnostic decision is undertaken next year.

4. Shiva Kumar S



Shiva Kumar S. belongs to the rural tribal BPL family. His father has studied up to 3rd standard. He works as a farmer. Mother is a housewife. They have agricultural land. They live in Gumachanahalli village which is 30Kms from the Mysore bus station. He studied from class I to class VI in the Government school in his village. His elder brother was studying in Kaliyuva Mane. He advised his parents to admit Shivakumar to Kaliyuva Mane. Shiva Kumar completed the X standard board

examination in English medium in the year 2021 from the 'Pragathi' team. Now he is pursuing II year PUC (commerce) from D. Banumaih's college.

5. Bhaskar:



Bhaskar belongs to a rural tribal BPL family. He lives in Gumachanahalli village which is about 30Kms from Mysore city. Parents are illiterates. His father is a farmer. His mother also works in the farm. Bhaskar studied from 1st to 6th standard in the Government Kannada medium school in his village. But his parents were struggling due to acute poverty unable to buy notebooks also. Some children from that village were already studying in Kaliyuva Mane. His parents admitted him to Kaliyuva Mane as a day scholar on 29-05-2017. Later he joined as a resident scholar on 24-01-2018. He passed X standard Board examination in the year 2021 from 'Pragathi' team,

securing 83.68% marks. He is pursuing PUC (commerce) in Maharaja College, Mysore.

6. Monoj K.



Manoj K belong to a rural BPL family. His family stays in Devalapura Village, Mysore. His father is uneducated and works as a mason. His mother is a house wife. He studied from LKG to class 3 in Arunodaya Vidyasikshana, Devalapura in English medium. He could not understand the lessons properly. His father admitted him to a government high school in Devalapur. He completed class 4 and class 5 in Kannada medium. There also he could not learn. So, he was admitted to Gopalaswamy Shishuvihara Higher Primary Shool, a private English medium school in Mysore. He completed 6th and 7th standard. He could not understand the lessons even there. So a teacher at that school

informed his father about Kaliyuva Mane. So on 14-04-2017, his parents admitted him to Kaliyuva Mane. At Kaliyuva Mane his parents were advised to take him to the Psychological Department of the All India Speech and Hearing (AIISH). According to their report his academic level was categorized as "Average Intelligence-Academic Delay with Learning Difficulties". His IQ: 100 and his overall educational level was at class 2. At that time his age was 12 years and 10 months. Kaliyuva Mane teachers started teaching him from letters and numbers. He passed the 10th standard board examination in 2021 scoring 71.3% marks. He is pursuing Diploma in paramedical (X-ray technician) in BGS institution His AIISH report is given in the next page.

As per records, the student is diagnosed as functioning at the level of "Average Intelligence-Academic Delay with Learning Difficulties". His current level of intelligence and adaptive behavior as assessed on standardized psychological tests is age appropriate (IQ: 100) with overall grade level equivalence matching class II. Past history shows normal developmental milestones.

The student shows difficulties in rote counting beyond 1000s, cannot solve multi-digit additions involving carry over and subtractions involving borrow operations, cannot solve multiplication problems and division sums with zero in numerator, fails to spell 3-4 letter words of class II upwards in English, lacks alphabet-sound correspondence for end consonants, or understanding of phonetic rules. He shows difficulties in reading-writing additional languages.

The student requires a structured learner paced remedial teaching program through the next two years before a final decision is made on the diagnosis of the child's condition during the next round of re-evaluation and follow up at this institute. Owing to his condition, the student falls under the category of 'children with special needs' or 'disadvantaged child' and becomes entitled for such illustrative list of benefits or concessions as mentioned overleaf especially those related to inclusion, avoidance of pressurized learning, providing learner paced instruction, to accommodate the academic slowness in the child.

He passed the 10th standard board examination in 2021 scoring 78.24% marks. He is pursuing ITI course in NIE College, Mysore.

8. Amith R



Amith R belongs to tribal family. His family stays in Mahadevapura, Mysore. His father has studied up to 10th standard and working as an Auto driver. His mother is a house wife, she has completed PUC. Amith has studied upto 7th standard from Bruhaspathacharya Vidyasamsthe. He was lagging behind in studies. They came to know about Kaliyuva Mane with the help of Sumanth's mother (old student of Kaliyuva Mane). Amith was admitted to Kaliyuva

Mane on 01-06-2018. Amith liked Kaliyuva Mane and started learning here. He passed 10th standard board examination in 2021 scoring 68.64% marks from Pragathi Scheme. Now, he is pursuing Diploma in Engineering (Electronics Communication) course.

9. Sohan



Sohan is from a BPL family. His father is not alive. His mother has studied up to P.U.C and she is working as a home nurse. Sohan and his family is living in a rented house. He studied class 8 in Shivananda Vidyasamsthe, Mysore. He was lagging behind in studies. His mother couldn't afford to pay the school fees as she was only the breadwinner of the family. So, he was admitted to Kaliyuva Mane. He passed the $10^{\rm th}$ standard board exam in the year 2021 by securing 92.6% from Pragathi team. Now he is pursuing Diploma in Automobiles at CPC Polytechnic, Mysore.

10. Arjun N



Arjun N belongs to socially backward family. His family stays Vinayakanagara of South Bangalore. His father has studied up to 6^{th} standard and working as a Lorry driver. His wife is a house wife, she has studied up to 10^{th} standard. Arjun studied LKG to 9^{th} standard in Holy Child English School, Bangalore. When he was in 10^{th} standard he fell sick and became very weak physically. So his father did not send him to school and made him rest at home for two months. He was also very weak in studies. So his father was looking for a new school for him. Arjun was referred to

Kaliyuva Mane by NIMANS (National Institute of Mental Health & Neuro Sciences) Bangalore. He and his son Arjun visited Kaliyuva Mane on 27-05-2019 and liked the environment here. An informal test was conducted to Arujun at Kaliyuva Mane. He could night write simple Kannada words. Kaliyuva Mane advised his father to take him to the clinical Psychology Department of the All India Institute of Speech and Hearing (AIISH). According to their report his IQ was 100, academic level was categorized as "Average Intelligence-Academic Delay owing to specific Learning Disability (Dyslexia). He belonged to the category 'children with special needs' having equivalent of 75% academic disability. Teachers started teaching him from basics. He passed the 10th standard board examination in 2021 scoring 84% marks. He is pursuing ITI course. His AIISH report is given in the next page.

Academic history and performance on achievement tests continues to show a current overall grade of primary-middle school level

He does not rote count numbers above 1000, does not solve three-digit subtractions with borrow operations, cannot solve divisions with zero in numerator, lacks arithmetic reasoning, cannot spell 4-5 letter words of class two upwards in English, lacks alphabet-sound correspondence for end consonants, or understanding of phonetic rules. He cannot explain basic concepts in science or geography, does not solve LCM/HCF, cannot explain fractions, prime numbers or integers, and does not give out formula for simple/compound interest or measurements in middle school level geometry. Past history shows normal developmental milestones.

Owing to his condition, the student is entitled to be considered as a candidate under the category of 'differently abled' as per government notification number A8.SSLC.Notification.April. 2014/13-14; Dated: 29.01.2014, for provisions like exemption from study of mathematics and science, first and third language, provision for study of alternative subjects like sociology, economics, and social science with regular social science and English as subjects. This report is issued during the ongoing pandemic with limited validity on application/request from the parent for purpose of taking class X examination under special category in this academic year.

Mysuru: Bhoomika, a former child worker, has scripted a remarkable success story one that will inspire many.

Bhoomika, who started working when she was se-

ven, has joined as a nurse at a private hospital in the city.

After completing her SSLC as a private candidate in 2020, she pursued a one year course for Auxiliary Nursing

Midwifery at a city nursing college. "I could not even dream of reaching here in my childhood," she told TOI.

Bhoomika, who hails from Devaiahanahundi in Mysuru taluk, lost her father

at a very young age. Her mother worked as a domestic help and construction worker to take care of her six children — five boys and a

girl. Unable to support the education of her daughter, she sent a 7-year-old Bhoomika to Bengaluru to take care of a one-year-old infant. Bhoomika worked as a child labourer for two years in Bengaluru.

"Bhoomika's mother was working as a domestic help at the house of one Uma, a resident of Srirampura. Uma, after coming to know about Bhoomika's plight, brought her to our

school in 2013," recalled MR Ananth Kumar, trustee of Kaliyuva Mane, a free alternative residential school.

"Bhoomika had no transfer certificate or Aadhaar card. She did not seem interested in learning in the beginning, but gradually she started showing interest. She participated in one All India Radio programme too. In 2020, she cleared the SSLC examination in English medium from the Pratibha team. Subsequently, she did a nursing course at Teresian College. A few days ago, she had come to Kaliyuva Mane with sweets," he said recalling Bhoomika's inspirationaljourney.

Bhoomika is yet to decide on higher education, he added.
